The **Tarakeshwor Rural Municipality Dangasing, Nuwakot** has allocated funds towards the cost of Upgrading of Tarukaghat- Kauchheni-Kaule Road, Chainage 5+200-8+700 and intends to apply part of the funds to cover eligible payments under the contract for Contract No. TRM/NUW/W/NCB/01/075-076. Bidding is open to all eligible as per section V of bidding document.
2. **Tarakeshwor Rural Municipality Dangasing, Nuwakot** invites sealed bids from Nepalese eligible bidders for the construction of Earthwork excavation in all types of soil under National Competitive Bidding Single Stage one envelope procedures. The estimated amount for the works is Rs.50,00,000 (Rupees Five Millions only).
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Tarakeshwor Rural Municipality, Dangasing, Nuwakot**.
4. A complete set of Bidding Documents may be purchased from the office **Tarakeshwor Rural Municipality, Dangasing, Nuwakot** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3000 (Three thousand only) till during office hours.

5. Pre-bid meeting shall be held at **Tarakeshwor Rural Municipality, Dangasing, Nuwakot** at 13:00 on 20th November 2018.
6. Sealed bids must be submitted to the office of the **Tarakeshwor Rural Municipality, Dangasing, Nuwakot** by hand/courier on or before **12:00** on **5th December 2018**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:00 on 6th December 2018 at the office of **Tarakeshwor Rural Municipality, Dangasing, Nuwakot**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of 1,21,000 (Rupees One lakhs twenty one thousand only), which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
